The meeting was called to order at 7 P.M. by Ryan Helmuth.

<u>Public Hearing on request for a Zoning Change.</u> Jeff Schuster, 8678 County Road K, Omro, WI, 54963, is requesting a zoning change for parcel 022 0600, Sec .28, T 18 N, R 14 E.

Applicant is requesting the property be rezoned Rural Residential (RR) from General Agriculture (GA). J. Kallas is purchasing .3 acres from Jeff Schuster to construct a building meeting all Town requirements.

Motion made by D. Stokes, 2<sup>nd</sup> by R. Lee, to accept the request for a zoning change for parcel 022 0660 from GA to RR. The motion carried.

<u>Public Hearing for a Conditional Use Permit.</u> Melissa Mahlke, 1125 Cumberland Trail, Oshkosh, WI, 54904, is requesting a Conditional Use Permit for parcel 022 031202, located at 8834 Edgewater Ridge Road, Omro, WI, 54963.

Applicant is requesting a Conditional Use Permit to construct an accessory building and live in part of it while a permanent home is built.

Some of the items discussed were:

- Lot was resurveyed and problems arose with neighbors home too close to the lot line.
- Neighbors septic is on M. Mahlke's property
- Neighbor Brian E. asked about location of the building, windows, and lights
- Possible purchase of J. Ermanns land by M. Mahlke
- Is applicant aware of all state requirements for building?
- Neighbor across the road, D. Zarling, was concerned about giving a Conditional Use
  Permit until all problems were solved

Motion made by Pat K., 2<sup>nd</sup> by Ryan H. to grant a Conditional Use Permit for parcel 022 031202 with the stipulation they live on the property within 3 years after approval by the

Town Board. The motion carried with a vote of 3 yes and 2 no to recommend approval by the Town Board.
