# Rushford Township Planning Committee Meeting April 25, 2018

Board and Committee Members Present: Zoning Administrator Tom Jackson, Town Clerk Peggy Hendricks and planning committee members: Town Supervisor Jerry Schoonover, Zoning Chairman Ryan Helmuth, Rob Resop, Nicole Bahn and Vice Chairman Dan Stokes. Additional attendee: Ralph King

The meeting was called to order at 7:00 P.M. by Chairman Ryan Helmuth.

### **Appointment of Zoning/Planning Committee Members**

- Three year terms for Zoning Chair Ryan Helmuth and Vice Chair Dan Stokes are up
- Next year in 2019, a two year term for committee board member Jerry Schoonover will be up as well as a three year term for Recording Secretary / committee member Nicole Bahn
- In 2020, a three year term will be up for committee member Rob Resop
- **ACTION ITEM:** Town Clerk Peggy Hendricks will create Facebook post on the town's site in an attempt to solicit new committee members
  - Helmuth stated he would serve again if there are no other interested parties but would be open to being replaced due to other commitments

## Public Hearing for Roger Bongert on Parcel 022-0891 located at 7131 County Road K, Omro

- Applicant is requesting a zoning change from general agriculture (GA) to rural residential district (RR) for Lot 1 of the pending CSM
  - No neighbors contacted anyone on the town board with concerns
  - This was the original building site
  - Existing driveway is okay
  - o Preliminary CSM has been completed
    - Lot 1 will be 1.68 acres
      - Friend will be constructing a home on the parcel
    - Remaining acreage will remain GA

**Motion made by Stokes, seconded by Schoonover:** Recommend approval to the town board for a zoning change to Lot 1 of the pending CSM for parcel 022-0891 from general agriculture (GA) to rural residential (RR). All voted in favor.

#### Public Hearing for Ralph King on Parcel 022-024102 located on State Road 21, Omro

- Applicant is requesting a zoning change from general agriculture (GA) to small estate residential (SER) for Lot 1
  - No neighbors contacted anyone on the town board with concerns
  - Property is located across from 7858 State Road 21
  - CSM had previously been completed when acreage had been split off for another child
    - Lot 1 is 4.174 acres
    - Driveway access off 21 will be shared between the parties (first 20')

**Motion made by Stokes, seconded by Schoonover:** Recommend approval to the town board for a zoning change to Lot 1 of CSM 6627 from general agriculture (GA) to small estate residential (SER). All voted in favor.

## **Old Business:**

- Copies of previous correspondence sent to 9133 River Road resident Edward Patrick were reviewed
  - Zoning Administrator Tom Jackson stopped in about a week ago, was not able to make contact with the owner
  - o Will continue to work towards a resolution regarding the unlicensed vehicles on the site
